# **VDOT Work Zone Traffic Control Training Program (WZTCTP)**

The Virginia Department of Transportation (VDOT) has established a mandatory Work Zone Traffic Safety Training Program (referred to by VDOT as the Work Zone Traffic Control Training Program or WZTCTP. It is based on Federal Highway Administration (FHWA) regulations provided in the Code of Federal Regulations (23 DFR 630 Subpart J) which states that:

"States (i.e., Virginia et.al.) shall require that personnel involved in the development, design, implementation, operation, inspection, and enforcement of work zone related transportation management and traffic control be trained, appropriate to the job decisions each individual is required to make."

This training became required effective July 1, 2009.

## HOW TO REGISTER:

### LEVELS OF TRAINING:

#### 1. Basic Training

This is a one-day "base" training course designed for VDOT maintenance managers, or private heavy construction workers or superintendents who have direct responsibility for the placement of work zone traffic controls and control devices.

2. Intermediate Training

This is a two-day training course designed for construction supervisors (foremen, superintendents, and private engineers or hired consultants) responsible for on-side inspection and placement of traffic control devices around state highways.

We cannot guarantee that every class will be held as we cannot control registrations. We try to make every effort to hold the class. However, C.S.V.U.C.A. reserves the right to cancel any class that does not meet the minimum registration requirement.
